Next APPGF meeting

The next meeting of the All-Party Parliamentary Group on Forestry is on Tuesday October 11th in committee room 21 in the Palace of Westminster, 1130am-1pm.

The event will include an update on Confor's work to shape a thriving post-Brexit future for the forestry sector, along with a panel discussion on forestry, devolution and Brexit including MPs from England, Scotland, Wales and Northern Ireland. A consultation on plans to fully devolve forestry to Scotland - The Future of Forestry in Scotland - was recently announced and in Wales, the National Assembly's Climate Change, Environment and Rural Affairs Committee has asked for ideas about the future support for agriculture, land management and rural communities.

After the last meeting of the APPGF, we published the Confor discussion paper on the potential impact of Brexit as an APPGF report, Shaping a post-EU future for the UK forestry sector.

We are again inviting a range of stakeholders from the forestry and timber sector to attend the October meeting and we hope you will join these important discussions.

Forestry Innovation Fund reopens

Everyone in the sector is delighted that the Forestry Innovation Fund has been re-opened to new applications.

When the £1 million fund first opened last December, an initial tranche of up to £200,000 to fund Woodland Creation Planning Grants saw ten planting schemes totalling more than 1000 hectares put forward. The

Confor will draw heavily on the blueprint for the future success of the industry which emerges from its post-Brexit consultation in its written evidence to the committee – and looks forward to giving evidence as we seek to shape the future in this rapidly-changing times.



Westminster conference

Confor looks forward to welcoming new Forestry Minister Dr Thérèse Coffey MP to another landmark conference at RICS' London in Westminster.

The three previous conferences have been very well-attended and brought together a wide range of interests to discuss major issues. With the aftermath of Brexit, full devolution of forestry to Scotland, the re-opening of the £1 million fund and the forestry inquiry, there is much to discuss – with a real focus on future rural land use funding and driving up planting levels in England.

UK, Confor established five workstreams to look into the big issues arising from the vote to leave the EU:

- How to ensure increased tree planting in the short, medium and long-term
- The future shape of rural policy and funding
- Legislation and better regulation
- Timber standards, trade and migrant labour
- Plant health

Technical Director Andrew Heald is co-ordinating the workstreams and Confor will publish a report with recommendations within the next month. The main aim is to identify practical recommendations which can help the sector thrive in the future, whatever that future looks like.
